WHEREAS the "First Party" is involved in the research, teaching, and extension in horticultural crops represented by its DIRECTOR, ICAR-IIHR (the institution which expression, unless excluded by or repugnant to the subject or context shall include its Successors-in-office, Administrators and assignee) AND WHEREAS the "Second Party", VIVEKANANDHA TRUST, as part of its capacity building of various primary and secondary stakeholders involved in Rural and horticultural Development. Vivekanandha Trust has been implementing various Socio-Economic, Agricultural and horticultural research, Educational, Cultural and Health Related programs for our target community people of Tamil Nadu represented by its President, Vivekanandha Trust (the Organization which expression, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assignee).

WHEREAS the parties, having discussed fields of common research, extension and training and allied activities between the two institutions, have decided to enter into long-term collaboration for promotion of ICAR-IIHR technologies in horticultural crops, and mutual efforts and capacity building.

AND WHEREAS it has been considered expedient to agree in writing to participate jointly in the issues requiring expertise and logistics from both the parties.

### Article 1. Scope

The First party will recognize the Second party as an collaborative Institute to provide the major technical guidance and local assistants about ICAR-IIHR transfer of technologies on horticultural crops, Joint Research development Project and capacity building provide to farmers as specified by ICAR-IIHR. The Second party may engage to Scientists of the ICAR-IIHR as recommended by its Director in accordance with guidelines on ICAR-IIHR. The ooperational details of ToT of IIHR technologies and capacity building restricted to specific mandated domain.

Research and Development facilities available with the First party and second party will be made available to the both parties as per the guidelines F.No.2-9/2012-HRD, dated on 25<sup>th</sup> April, 2014. However, the costs of specific consumables/ planting materials will be borne by the respective organizations.

There shall be an expert visits for academic, research and training purposes. The duration of exchange visits will be determined by mutual consent between both the parties, and the expenditure incurred may be met by collaborative projects / programmes.

# Article 2. Management

Director of the First party and the President of the Second party will be responsible for working out the operational details of co-operation between the two organizations and ensure proper and effective implementation of this MoU.

There shall be a team of scientific advisors from ICAR-IIHR to evaluate the ICAR-IIHR technologies where implemented, and 2-3 members from the Second party. The committee will meet as per the need alternatively in the institutions of the First party and the Second party to review the activities. This meeting shall include presentations by both parties on various research activities followed by mutual concern.

### Article 3. Exchange of Information

The term "information" includes scientific or technical data, results and/or methods of investigation, and other information intended to be provided, exchanged, or arising under field experiments entered into pursuant to this MoU.

Both parties shall support the widest possible dissemination of the information. Both parties shall be given the right to use, disclose, publish or disseminate such information for any and all purposes with due credits of the other party.

#### Article 4. Exchange of germplasm/biological materials

Any exchange of germplasm or other biological materials is required during the period should be done through execution of MTA (Material Transfer Agreement) and the guidelines specified in the MTA needs to be followed.

#### Article 5. General Provisions

It is understood that the First party and the Second party subscribe to the principle of equal opportunity and do not discriminate on the basis of race, sex, age, caste or religion. Both the Institutions shall abide by these principles in the administration of this agreement and neither party shall impose criteria for exchange of scholars, which violate principles of non-discrimination.

Both parties acknowledge that exchange of technologies/technical knowledge from one party to the other shall comply with the regulations and policies of the First party and the Second party.

Any research publications arising will be jointly published in accordance with the provisions laid out by both parties.

All questions related to this MoU arising during its term will be settled by the parties by mutual agreement. Disagreements at the operating level shall be forwarded to respective higher officials for appropriate resolution failing which an arbitrator of mutual acceptance may be identified for the settlement of dispute, if any.

Nothing in this MoU is intended to affect other cooperation or collaborations between the parties.

## Article 6. Intellectual Property Rights

Both parties are expected to ensure protection of the Intellectual Property Rights generated or likely to be generated during the collaborative research work. The ICAR-IIHR as the first applicant (for its institute) and the Second party shall be the joint applicants for IPRs and the scientific staff involved in such research shall be included as the innovator/inventor/breeder/author. The 'ICAR Guidelines for Intellectual Property Management and Technology Transfer/Commercialization' as amended from time to time shall be the reference for exploitation of the generated intellectual property, whose management and benefits sharing shall be mutually decided in each case.

#### Article 7. Entry into effect, modification and termination

This MoU shall become effective on the date it is signed by the parties and shall be valid for five years in first instance. The period of validity of the MoU may be extended by mutual consent up to 3 (Three) years. Both parties shall review the status of the MoU at the end of each year period as the case may be, to determine any modification, whenever necessary. This MoU may be amended by mutual written agreement and may be terminated at any time by either party upon written notification signed by the competent authority of the party initiating termination. Such notification must be given to the other party. Such notification must be given to the other party at least six months in advance from the effective date of termination.

All collaborative activities not completed at the expiration or termination of the MoU may be continued until their completion under the terms of this MoU.
